Buena Vista Lagoon, San Diego County - Land Acquisition

\$560,000.00

Mr. Nesbit reported that the initial acquisition of land at Buena Vista Lagoon was approved by the Wildlife Conservation Board in January, 1969. Since that time the Board has purchased the Palomar Savings and Loan property and has arranged for the transfer of the Nature Conservancy lands to the State without cost. At the June 28, 1972, meeting, the Board instructed staff to negotiate with the two remaining owners of land considered by the Department of Fish and Game to be of high wildlife value. These are the properties east of Highway 5 and are owned by Buena Vista Limited (Mr. Donald Wells, et al) and by Mr. Bernard Citron, et al.

FOR FEDERAL LAND AND WATER CONSERVATION FUND AS APPROPRIATE.

Minutes of Meeting, Wildlife Conservation Board November 13, 1972

Appraisals have been made on both properties and the owners have agreed to the fair market value price as indicated in the appraisals. These properties are adjacent to each other, but have different values because of access and development potential.

Minutes of Meeting.

The Wells property (33^{\pm}) has been appraised by a private appraiser as having a fair market value of \$298,500 or \$9,000 per acre. Mr. Wells had some resistance to this price, since it is considerably lower than the Division of Highways purchase of the adjoining land. Mr. Wells has, however, agreed to sell to the WCB rather than carry out his intentions to fill the lagoon and develop it commercially.

The other property on the agenda for purchase was the 23 acres owned by Citron, et al. It adjoins Jefferson Blvd. and has a potential for either high rise or shopping center development. Mr. Citron developed a shopping center on some adjoining land and in doing so violated Section 1602 of the Fish and Game Code. As mitigation for the 3.5 acres of marshland previously filled, Mr. Citron has agreed to dedicate \$25,000 of the appraised price to be used to re-create wildlife habitat in the lagoon on the lands to be acquired from him and on other state lands. The Department of Fish and Game will administer these funds for that purpose. The Attorney General has prepared such an agreement which will assure the use of these funds for wildlife purposes. The Citron property is appraised at \$250,000 or \$10,870 per acre.

Mr. Citron has asked that his sale be consummated during calendar year 1972 and staff has agreed to do all possible to see that this is done.

At the last WCB meeting staff reported there was a possibility of obtaining these purchases on a "no appropriation basis", using the value of the gift-deeded land from Nature Conservancy as the state contribution for matching Federal Land and Water Conservation Fund reimbursement. An application for this purpose has been made, but it is possible that the Nature Conservancy lands may not qualify for such reimbursement. We are practically assured, however, that regular 50 per cent Land and Water reimbursement for the acquisition and development costs for the Wells and Citron properties will be approved.

Mr. Nesbit advised that an allocation of \$560,000 from the Wildlife Restoration Fund will be required to consummate these acquisitions, but at least one-half of this would be recovered if the acquisition qualifies for federal fund reimbursements. Staff recommended purchase of both properties as these two parcels are a key part of one of the WCB's most important habitat projects in Southern California

The Chairman recognized Assemblyman Stull who thanked the Board for its action which will bring to fruition the long-standing effort on the part of citizens of this State to preserve the fresh water lagoon as a unit of the flyway on the coast. He acknowledged that there has been a lot of hard work in this effort which included legislation as well as involvement by staff and other interested agencies and private citizens.

Mr. David Rorick, representing Nature Conservancy and in behalf of the communities of Oceanside and Carlsbad, expressed profound gratitude for purchase of this area which will complement the properties already acquired by the State.

Mr. Lawrence Bagley and Councilman Glen McComas of Oceanside echoed the thanks of Mr. Rorick and Assemblyman Stull for the action taken by the Board and advised that their community has been a part of this effort for several years.

6. Aqueduct Fishing Access, Kings County (F&W Enhancement Bond Act Funds)

Kettleman City Fishing Access, Kings County Avenal Cut-Off Fishing Access, Kings County \$15,000.00

It was requested by Assemblyman Gordon Duffy and so ordered by Chairman Russ that the Board consider at this time the aqueduct fishing access projects.

The Executive Officer remarked that originally only the Kettleman City site was to be included on this agenda. However, with Assemblyman Duffy's good work, it was possible to have the plans prepared for the second site, a development which was believed very desirable and necessary by the County of Kings.

Aqueduct projects are among those selected for funding under the Recreation and Fish and Wildlife Enhancement Bond Act of 1970, and in anticipation of such a request, staff had included funds in the 1972-73 budget for aqueduct development in Kings County.

The Department of Fish and Game has determined that populations of both striped bass and white catfish, as well as other species, are present in numbers sufficient to warrant the development of fishing access sites. The Department recommends these sites be developed.

The Kettleman City site is within one-half mile of Kettleman City and but a short distance from the Interstate 5 freeway. Development would be at the lower side of a check structure, an area where both bait and game fish tend to concentrate.

The Avenal Cut-Off site is adjacent to a well-traveled road leading from Avenal to Hanford, Visalia, Fresno, and other sizeable valley cities.

Both sites would be available to residents of Kings, Tulare, and southern Fresno counties, as well as people using nearby Interstate Highway 5. The area is woefully lacking in fishing opportunities and is about midway between WCB fishing access sites already developed or planned.

Development at each will consist of paved berms or walkways along the aqueduct, graveled parking areas, fencing, steps, and sanitary facilities. Safety devices would be furnished and installed by the Department of Water Resources. The WCB's proprietary interest would be obtained through a permit from the Department of Water Resources. Construction would again be carried out by DWR as has been done at the several other sites.

Environmental impact statements for the two projects were made available for review by the Board. The results of the environmental impact study indicate there will be no adverse environmental impact caused by project construction or operation.

Mr. Nesbit reviewed for the Board members what had transpired on this acquisition since the June 28, 1972, meeting at which time the Board had instructed staff to obtain an independent appraisal of the property under consideration. The property, he reported, consists of a 482 acre potential ecological area of tidal flats and fresh water marsh, as well as a proposed fishing access consisting of a 21-acre strip with 5,800 feet of frontage on Tomales Bay, and a very important 13 acre fishing access area along Papermill Creek adjacent to Sir Francis Drake Highway.

The appraiser selected was Mr. Burl Howell of Santa Rosa who was at the meeting to provide testimony in support of his appraisal which was 1 \$313,750.

The Department of General Services upon reviewing Mr. Howell's appraisal, made a re-evaluation of their earlier appraisal and now agree with Mr. Howell's value on two of the three parcels owned by Mr. Giacomini.

The owner had rejected the original appraised valuation and has counter-offered to sell the property for \$240,000, but excluding the 80-acre fresh water marsh.

Mr. Nesbit reported that a letter was directed to the Department of Fish and Game asking if the deletion of the 80-acre fresh water marsh would be proper. The Director responded that the fresh water marsh was a most important part of this ecological area and that it would be wrong to exclude it from the reserve and leave it as a duck club. If this concept is accepted by the Board, the alternate proposal by the owner must be TO PROCEED WITH THE PROJECTS SUBSTANDATO AS PLANMED, STAFF IS FURTHER AUTHORIZED TO TRANSFER FUND

Mr. Vaughn Miller, Chief Land Agent for the Department of General Services, testified that the original appraisal by his Real Estate Services Division was \$200,500. The figure the Division recommended after the Howell appraisal was received was close to an average of the two appraisals. This is the point at which negotiation is right now. He also referred to the counter-offer by the owner who wished to keep the 80 acres. Mr. Miller recommended the Division be permitted another two weeks to negotiate with the owner for he felt they were very close in price.

Assemblyman Townsend felt that the state has been dragging its feet entirely too long on this acquisition and suggested that the Board offer the owner a price midway between the Department of General Services revised appraisal and the most recent independent appraisal; or a figure rebrof \$285,000 more or lessing insbragable as nietdo of consideration. The property, he reported, consists of a 482 acre potential

Mr. Miller stated that a compromise offer of \$256,000 had been made to the owner only recently. This figure is the re-evaluation upward of the appraisal made by his Department and was the only price his office could approve for negotiation. Upper Klamath River Fishing Access, Siskiyou County \$85,000.00

November 13, 1972

Mr. Nesbit reported that the County of Siskiyou has recommended the acquisition of 38 acres of land along the Klamath River for fishing access purposes. By resolution, the County has agreed to operate and maintain the area for a long-term period, open and free to the public. Along with the acquisition, only modest development would be needed.

The property is located on the left, or south, bank of the Klamath River, about 20 miles northeast of Yreka. Over 3,000 feet of river frontage is included. The proposal is in compliance with the WCB's policy of providing fishing access to inland waters.

The Klamath is renowned for its salmon and steelhead fishing. Much of the mid and lower Klamath flows through national forest land and access is no great problem. The upper portion between Interstate Highway 5 and Iron Gate Dam, however, is almost entirely on private holdings. Fishing in this area is generally by invitation only, and the general public has difficulty in obtaining land owner permission to fish.

The Department of Fish and Game, in their fisheries evaluation, recommended the acquisition and pointed out the urgent need for public fishing access in this area.

In recent years several large blocks of land embracing both sides of the upper river have been purchased by outside interests for development into home sites or as private recreational areas. If the State does not acquire the property being considered in this agenda, it is entirely possible it would be acquired and developed in a similar manner by private persons. In this event public access would no doubt be further restricted.

Mr. Nesbit reported that on February 21, 1968, the WCB approved construction of a fishing access project at Lake Piru and allocated \$48,300 for the facility consisting of a boat launching ramp and parking area.

The reservoir, an impoundment of the United Water Conservation District, is located in eastern Ventura County. It provides recreation benefits

The ramp provides boat access to the reservoir during most of the normal operating levels. There are, however, extended periods when the reservoir level is above or below the ramp. 10. Channel Islands Harbor Access, Ventura County

The Board was informed by Mr. Nesbit that Ventura County has requested consideration of a proposal to expand the existing WCB fishing access facility constructed at Channel Islands Harbor in 1964. The Board allocated \$61,300 for the initial developments which consist of a 4-lane concrete boat launching ramp, two loading floats, a parking area and restroom.

Public use of this access has more than doubled in the eight years since it was first constructed. There is a critical need for another lane on the boat ramp to alleviate congestion and long waits in the pre-dawn hours by fishermen who like to start early.

There is also a need for day-use docking facilities for the convenience of fishermen who wish to come in for short periods to use the restroom or to have lunch with their families on shore.

The proposal presented by Ventura County provides for the additional lane on the ramp and a float for short term tie-up. A walkway is also planned to provide access from the float to the restroom. Staff has observed the use which the project has received and agrees that these improvements are needed.

The County has agreed to extend the term of the lease to provide for a 25-year term from this date and to continue to maintain all the facilities during this period. The County Department of Airports and Harbors has maintained the project well since its construction and has made some improvements on their own. The major improvements added at County cost have been the expansion of the parking area, landscaping and the addition of some floats.

The upgrading of existing projects is in accord with the practice of the Board to do so where the use of such projects has grown substantially and where the existing facilities have become inadequate.

Mr. Nesbit advised that this item does not require an allocation of funds and is a proposal to change operation and maintenance responsibilities from Placer County to the Tahoe City Public Utility District.

The Lake Tahoe Fishing Access, located just east of Tahoe City on the State-owned hatchery property, was approved by the Board in 1961, and

\$74,800 was allocated for the project. A boat launching ramp, pier, floats, parking area, restroom and access road were constructed, and maintenance responsibilities were assumed by Placer County.

At the March 23, 1971, meeting, the Board approved the construction of, and allocated \$48,300 for a breakwater to provide a safer launching area and to protect the ramp and pier from damaging wave action. This improvement has been approved by the State Lands Commission and the Tahoe Regional Planning Agency, and construction is expected to be completed next year.

Placer County developed an overnight campground on a portion of the property and this has added to the public use of this access. The campground has not been open continuously, however, as the County has found it difficult to operate such a facility in the Lake Tahoe basin from their operating base in Auburn.

The County has arranged for routine maintenance of the fishing access area by the Tahoe City Public Utility District, and this has been satisfactory as a temporary measure. More direct maintenance responsibility is needed, however, and this change in local cooperating agencies would accomplish that.

The County has by resolution requested that the cooperative agreement with them be terminated subject to their maintenance responsibilities being taken over by the District. The District has also by resolution, agreed to enter into a cooperative agreement with essentially the same terms as presently exist.

Mr. Nesbit believed this transfer of operation and maintenance responsibilities to the Tahoe City Public Utility District will be an improvement with direct public benefit. The District office is in Tahoe City, just a short distance from the project. A recreation district has been formed under the Utility District, and an experienced Recreation Director is on their staff. The reopening of the campground and other desirable improvements at District's cost would be possible, as well as better maintenance with this change.

Mr. Nesbit recommended the approval of this change, and requested authorization of staff to proceed with the execution of the necessary agreements to effect the transfer of operation and maintenance responsibilities of the Lake Tahoe Fishing Access from the County to the Tahoe City Public Utility District. He introduced Mr. Ken Milam from the County of Placer and the three representatives of the Tahoe City Public Utility District: Bill Layton, General Manager; Ted Mastain, Director of Parks and Recreation; and Earl Jackson.

Mr. Layton declared that the District was formed many years ago to serve the community with water and more recently to provide sewage service. In the last two years, it has taken on recreation responsibilities and to implement their recreation program has hired a Director of Parks and Recreation.

Mr. Mastain, Director of Parks and Recreation, stated they are most anxious to take over operation and maintenance and intends to accomplish this in a first class manner. It is the District's plan to operate a camping area in conjunction with the access facility.

Mr. Ken Milam, representing the Placer County Board of Supervisors, expressed the desire of the County to withdraw from the operation and maintenance responsibility at Lake Tahoe in favor of the District. He explained that this launching ramp at Lake Forest is the only free ramp in north Lake Tahoe and therefore was a much-needed facility, but the County has found it difficult to operate it properly from their operating base in Auburn.

Mr. Nesbit advised that on October 9, 1969, the Board allocated \$19,000 for the purchase of two parcels of land adjacent to Noyo Harbor District property on the Noyo River for fishing access purposes. At that time, it was explained that the District proposed a WCB allocation at a later date for the development of facilities at this site for boat access to the river.

The land acquisition has been made and the Harbor District has completed preliminary plans and a cost estimate for the construction which will consist of a boat ramp, parking area and floats. Staff has reviewed the plans and has found that they are in line with the concept as originally proposed.

The District will complete construction drawings, bid out the project, and supervise the project during construction. A resolution submitted by the District Board of Directors declares that the District will provide a free long-term lease of a portion of their property needed for the boat ramp. The parking area will be located on the property acquired by WCB. The District's resolution also states that the District will maintain the entire area and keep it open free of charge during the term of the lease.

At the October, 1969, meeting the Board was informed that there was a real need to replace the existing boat launching facility which consists merely of the end of the old county road. In the past three years the conditions there have grown worse and congestion has increased as ownership of seaworthy trailer-borne boats has increased. The new ramp will provide a safe, adequate and convenient boat access to the lower Noyo River and the Pacific Ocean for fishing purposes. The parking area will
