# ORDER ALLOWING CHANGE IN POINT OF DIVERSION AND PLACE OF USE

WHEREAS a petition was received February 5, 1931 to change the point of diversion and place of use under Application 1692 Permit 1053 and,

WHEREAS it has been established to the satisfaction of the Division of Water Resources that said change will not operate to the injury of any other appropriator or legal user of water and the Division of Water Resources so finds.

NOW THEREFORE it is hereby ordered that said point of diversion be and the same is hereby changed

A point located N. 27° 32' E. 1595 feet from the south quarter FROM:

corner of Section 18, T. 10 N., R. 12 E., M.D.B. & M.

TO: A point located N. 300 05 30 E. 1583.3 feet from the south

quarter corner of Section 18, T. 10 N., R. 12 E., M.D.B. & M.,

being within the NW1 of SE1 of said Section 18,

and that said place of use be and the same is hereby changed

FROM: A place of use consisting of 12,575 acres in Townships 10 and 11 N.,

Ranges 9, 10 and 11 E., M.D.B. & M., as shown on map filed

February 27, 1920.

TO: A place of use consisting of 30,702 acres within the boundaries of

the El Dorado Irrigation District as shown on map filed April 8, 1927.

IT IS ORDERED that permission be and the same is hereby granted to change the point of diversion under said Application 1692, Permit 1053, to a point of diversion described as follows to-wit:

NORTH 27° 32 'EAST 1595 FEET FROM THE SOUTH ONE-QUARTER CORNER OF SECTION 18, T 10 N, R 12 E, M.D.B.&M., BEING WITHIN THE  $NW_{4}^{1}$  OF  $SE_{4}^{1}$  OF SAID SECTION 18.
