Gentlemen:

At the request of the Department of Finance, we obtained preliminary title report on the site of the proposed Letts Valley Dam. A copy thereof is enclosed for your information, together with a copy of letter dated May 1, 1958, from the Colusa County Title Company. From this, apparently a "wild" instrument has clouded the title of a portion of the property vested in the United States of America.

To clear this matter for purposes of the Letts Valley Dam Project and as a matter of clearing title for your own purposes, we have prepared and are enclosing herewith a quitclaim deed from Glenco Forest Products, a California corporation, to the United States of America, to facilitate your handling.
