Incumbent works in Fisheries Branch on the Central Valley Angler Survey (CVAS). The CVAS is a scientific survey that estimates angling effort, catch, and harvest of sport fishes in the entire Sacramento River system. This position is stationed in CVAS' Red Bluff office, providing project support on the upper Sacramento River and tributaries. Incumbent assists the Environmental Scientist by training, directing, and monitoring the performance of seasonal staff in the safe use and maintenance of small boats used for collection of biological data. Duties include instructing staff on basic boat trailering, towing, operation, rules, and safety. Incumbent also assists the Environmental Scientist as on-the-ground lead in the direction of seasonal staff in field work involving the collection of data from sport anglers. Following standardized protocols, incumbent trains and mentors seasonal staff in making personal contacts and conducting verbal interviews by boat at specific field locations and times, and recording prescribed data on standard forms. Duties also include equipping, maintaining, operating, repairing, and assigning project vehicles and vessels, including jet boats, drift boats, and kayaks, for angler survey work and other biological research activities. Incumbent performs semi-skilled tasks relating to the design, fabrication, operation, and maintenance of sampling gear using common power tools. Incumbent must be willing to regularly work odd hours, weekends, and holidays, and to work in extreme weather conditions. Physical abilities include lifting at least 40 pounds and working from small, open boats on a large river under challenging conditions.
