"For YCWA, the Yuba Salmon Partnership Initiative, which builds upon our work several years ago with the Lower Yuba River Accord, will contribute to the recovery of salmon and steelhead, consistent with the NMFS 2014 Recovery Plan. The reintroduction would be part of a Settlement Agreement that would include provisions to protect YCWA and other interests throughout the Yuba River watershed from liability under federal and state endangered species acts with respect to the reintroduction, and provide certainty to YCWA for its future operations of its systems of dams and reservoirs. Continuing to enhance fisheries habitat in the Yuba River will be expensive. YCWA's commitment of up to \$100 million for this initiative is a terrific jumpstart to the program, but long-term success will require the leadership and support of all of the initiative's partners. We're counting on all of our partners to help fund the program through its 50 year life."
